Comparative effects of flaxseed oil and vitamin E on non-invasive markers of liver in patients with nonalcoholic fatty liver disease.

Protocol summary

Summary

Objectives: Prescribing Flaxseed oil on the non invasive liver marker's in patients with non-alcoholic fatty liver disease. Design: Interventional- Not blinded. The major inclusion criteria are: The enzyme Aspartate Aminotransferase (AST) and Alanine Aminotransferase (ALT) at least 1.5 times above the normal limit, confirmed by the kidney sonography; Meeting at least one of the following criteria: Within the age range of 15-60 years old, diabetes, Hyperlipidemia, and Obesity. The major exclusion criteria are as follows: Consuming alcohol or having a history of drinking problems; Positive serology for viral hepatitis (C , B); Positive Anti-Nuclear Antibody (ANA) or Anti-Mitochondrial Antibodies (AMA) tests, Alpha-1 antitrypsin; Reduced serum levels of ceruloplasmin or increasing levels of Anti-smooth muscle (ASMA) and Liver kidney microsomal type 1 antibody (LKM1) antibodies; Ferritin level larger than 450, or Iron and Total iron binding capacity (IRON/TIBC) less than 45%; The patients being diagnosed with acute or chronic illnesses which cause disorders in LFT (liver function tests), before or during the medical intervention; the patients' consumption of drugs, before or during the medical intervention, which cause disorders in LFT; Pregnancy; Age less than 15 or above 60 years. Target sample size: 60 people Intervention group: Oral Flaxseed every day 3 times (1 gr) for 2 months; Control group: Oral E Vitamin 3 times a day for 2 months. Main outcome measure: Liver Enzyme (at the admission and 2 months after applying the intervention).
