Clinical trial to evaluate the effect of Extract zataria multiflora on clinical sign in Perennial Allergic Rhinitis compared with placebo

Protocol summary

Summary

The aim of this study is evaluating the effect of Extract zataria on clinical outcomes in patients with permanent allergic rhinitis. In this study 43 patients with signs and symptoms of allergic rhinitis, approved by the allergist were involved in Phase III double-blinded clinical trial in level of patient, researcher and they were located in groups of Extract zataria and control. Participants completed SNOT-22 forms and treated with placebo and Extract zataria for two months. Primary and secondary consequences according to this questionnaire included sleep disorders, sneezing and nasal congestion Inclusion criteria is affecting Verified allergic rhinitis and Exclusion criteria are taking other drugs with antioxidant or anti-inflammatory effect and any herbal medicine and pregnancy. Then, after the loss of patients during the study clinical and laboratory data processed in Two groups of fifteen (n = 30).
