Comparison of topical 1% Clotrimazole and Sertaconazol in treatment of erythrasma

Protocol summary

Summary

The purpose of this study is to compare of therapeutic effects of topical 1% clotrimazole with topical sertaconazole in the treatment of erythrasma. Inclusion criteria are patients with documented erythrasma with no topical treatment in recent 30 days and with no sensitivity to each of those drugs. Patients with any systemic disorder which may cause by all such as diabetes or patients with drug reactions will be excluded. We will prescribe topical 1% clotrimazole twice daily for one group and topical serbaconazole twice daily for another group. Treatment will last for 15 days and response will be documented in a questionnaire. Each group includes 20 patients.
