Objective: Determine Effect of Implementing Partners Training on the Quality of Life of Pregnant Women.

No difference in the lives of his wife, no misadventure of 6 months, Singleton pregnancy, no history of infertility. Exclusion criteria: Complete a questionnaire incomplete. (Up more than 10% completed the questionnaire); noParticipate male ; Divorce; abortion. The study population: Pregnant women who present to the Doctor Ali Shariati hospital. Sample size: A total of 60 people. Intervention: Education husband. Study time: from 2016-10-11 to 2016-11-21. The primary outcome: Improve the quality of life in pregnant women.
