Protocol summary

Summary

The goal of this clinical intervention is to empower clients with family-centered empowerment to improve quality of life and activity daily living. This study was designed based on a family-centered empowerment model on quality of life and activity daily living of clients with permanent pacemaker. A clinical trial was double blind (Related to study subjects (patients), Committee for the Study of Study Information (Information analysts are in the middle or end stages of the study) that conducted on 60 clients that contrive permanent pacemaker who had entered the study, randomly divided into two groups of intervention and control. Interventions during family-oriented sessions A family-centered empowerment model has a step-by-step implementation phase that should be interconnected and integrated. These four main steps, which are based on the family-center empowerment model, are: Includes: 1. Increased perceived threat by increasing knowledge. 2. Promoting self-efficacy by using problem-solving method. 3. Increasing self-esteem through educational participation. Step 4-Evaluation. Prior to the start of the steps, a questionnaire for quality of life and activity daily living is carried out by two groups of control and after 8 weeks educated, we filling the questionnaires of activity daily living and quality of life from two group for analyze. finally I get control group education in one sesstion and get them pamphelats and books.
