Comparison of effect of ringer's solution and lactated ringer as prime solution on acidosis and lactate level in noncyanotic pediatric cardiac surgery

Protocol summary

Study aim

effect of ringer and lactated ringer as prime solution on acidosis and lactate level in noncyanotic pediatric cardiac surgeries

Design

50 children undergoing open heart surgery are randomly divided into two groups. This clinical trial with two parallel groups will be double blinded.

Settings and conduct

This study will be conducted in the operating room of Shahid Rajaei Heart Center and patients and the surgical team will be unaware of the type of solution used.

Participants/Inclusion and exclusion criteria

Inclusion criteria: Children with non-cyanotropic heart disease, Having consent from the parents of the patient, Non-emergency surgery, Absence of coagulation disorders. Absence of anemia (hemoglobin less than 10 g / dl), Absence of hepatic impairment, Absence of kidney failure, Absence of lung failure, Absence of diabetes, Absence of acid disorder and severe preoperative hypertension, Lactate levels greater than 2 mM per liter before surgery, Not having a history of heart surgery (redo) Exclusion criteria: Periods of arterial blood pressure reduction before surgery, Ultrafiltration during bypass

Intervention groups

Intervention group, lactated ringer 350 to 400 cc, once at onset bypass. Control group, Ringer's solution 350 to 400 cc, once at onset bypass.

Main outcome variables

The variables of pH, Bicarbonate, Base Excess, Chloride, Lactate and the amount of sodium bicarbonate injected will be recorded.

Description

Intervention group: In the first group, a lactate ringer solution will be used to prepare the cardiopulmonary bypass system. Also, the venofundin 6% etherified starch solution at 15 cc / kg body weight, heparin 3 units per ml of prime solution, sodium bicarbonate at 24 mEq / l of prime solution and Mannitol 0.5 grams per kilogram of body weight will be added. In the case of low hematocrit, packed cell will also be used. The amount of lactated ringer solution will be about 350-400 cc and once at the start of the bypass. The Ringer Lactate solution is the product of Shahid Ghazi Tabriz factory and made in Iran.

Description

Control group: In the second group, a ringer solution will be used to prepare the cardiopulmonary bypass system. Also, the venofundin 6% etherified starch solution at 15 cc / kg body weight, heparin 3 units per ml of prime solution, sodium bicarbonate at 24 mEq / l of prime solution and Mannitol 0.5 grams per kilogram of

body weight will be added. In the case of low hematocrit, packed cell will also be used. The amount of Ringer's solution will be about 350-400 cc and once at the start of the bypass. Ringer's solution is the product of Iranian Pharmaceutical & Parenteral Products factory and made in Iran.
