The effect of physical activity labeling which indicates the amount of physical activity needed to burn energy of chosen food, and traffic light labeling on food choice

Protocol summary

Study aim

The purpose of this study is to compare the existing food labels (traffic light label) with a new label which will be designed by the researchers.

Design

This study will be conducted in qualitative and quantitative phases. Step 1: Assessment of current status of labeling In this section, the strengths and weaknesses of existing labels will be explained. Step 2: designing a new label and testing interventions Number: 500 Mother Mothers randomly will enter into 5 groups. First group: without nutrition label, second group: traffic light label (without informing mothers) - Third group: traffic light label (by informing mothers via brochures) - Group 4 physical activity labels (without informing mothers) - Group 5 physical activity labels (by Informing mothers via brochures). The brochures will be sent with an invitation.

Settings and conduct

Intervention in schools will take place. Mothers are not aware of the main purpose of the project, and the investigator is unaware of the division of mothers in each groups.

Participants/Inclusion and exclusion criteria

Include: Participants are mothers who can read and write. They also want to participate in the study. Exclude: Pregnant, lactating or diseases such as diabetes, allergies, etc. and diets.

Intervention groups

To assess the impact of new label, the school community will be used. They will be randomly selected from elementary schools from both sex groups.

Main outcome variables

Total calories of selected products in each groups are considered as the final result.

Randomization description

To evaluate the effect of physical activity labeling, schools from Tehran will be assigned. Block randomization will be considered. Tehran will be divided into five regions: north, south, east, west and center. two schools from each region will be randomly selected. Preschool and elementary schools (girls or boys) will be included. Fifty mothers will be randomly enrolled from each school, Then selected mothers will be divided into five groups. A total of 500 mothers will be included.

Mothers will be not aware of the aim of the study, so their food choices will be not affected. The divisions will be done by an expert and the researcher will not aware of it.

Intervention groups**1****Description**

Intervention group number1: physical activity labeling: After designing physical activity label in the first step, it will be produced by a printing office and will be fixed on products (dairy products- beverages- cakes and biscuits). It will be asked from mothers to assume that they are a supermarket and choose from the products that are available. This label will compare with the traffic light label which is currently in use. Mothers will only encounter this label once. one hundred mothers will participate in this group.

Intervention group number 2: physical activity labeling via brochure: Physical activity label with brochure: In this group, an educational brochure for choosing healthy food will be given to one hundred mothers, so the effect of education on choice is taken into account. The results of this group will be compared with the traffic light label group via brochure.
