The effect of semi sitting position on Post Dural Puncture Headache in Women undergoing elective Cesarian Section.

Protocol summary

Study aim

Survey the Effect of Head up Position after Spinal Anesthesia, on Incidence of Post Dural Puncture Headache (PDPH).

Design

Randomised, superiority, parallel group trial with blinded outcome assessment. 110 Woman that have Cesarian Section Randomly will be divided in 2 groups; group 1(intervention groupe) recieve Head up position in the Recovery time. and group 2 recieve Supine position at that time. By using Numerical Rating Scale(NRS), We will mesure patient`s post dural punctuer haedache(PDPH) by 5 days after surgery. Data will be collected and studied by Statistical Methods.

Settings and conduct

This study is a randomized double blind clinical trial. In Rafsanjan City and Niknafs Hospital; Womans that have spinal anesthesia for Cesarian Section will participate in the study after Conscious satisfaction. and randomly divided in 2 group; in the recovery time we will using headup position(30 degree) in intervention groupe and head flat position(0 degree) in control groupe. after 5 days we will mesure incidence of Postdural Puncture Headache in each groupe.

Participants/Inclusion and exclusion criteria

Inclusion Criteria: Woman by age 19 to 49 years old, ASA Class I, II and Weight from 50 to 85 KG, That have Cesarian Section with Spinal Anesthesia. Exclusion Criteria: history of Druge addiction, history of Migrane and chronic Headache.

Intervention groups

In Intervention groupe; We using Head up position(30 degree) in the end of surgery and in the recovery room. In control groupe; We using flat position of head(0 degree) in the end of the surgery and in the recovery room. We will have one Intervention groupe and one Control groupe.

Main outcome variables

Post Dural Puncture Headache is a positional Headache

in frontal region, that percepts 2 to 5 days after spinal anesthesia. We mesure presense or absence of PDPH , By using Numerical Rating Scale(NRS) 5 days after surgery.
