Comparative study of the effect of lavender, rosemary and orange essential oil on retrospective, prospective memory and drug compliance in hemodialysis patients

Protocol summary

Study aim

Effect of Lavender, Orange and Orange Essences on Retrospective, Prospective, and Pharmaceutical Follow-up in Hemodialysis Patients

Design

Clinical trial with control group, with parallel groups, non-blind, randomized minimization, with sample size 128

Settings and conduct

All patients with hemodialysis who are eligible to study in the dialysis departments of Shafa Hospital and Javad Alaeman, affiliated to Kerman University of Medical Sciences, are the sample of the study. Patients are entered into the study with available sampling method and are divided into four groups in the form of a lottery.

Participants/Inclusion and exclusion criteria

Not having any personality disorder with your doctor's diagnosis Not having chronic respiratory disease History of at least 6 months hemodialysis; If you need to be admitted during the study In case of allergy during the study

Intervention groups

In the control group, only the usual care of the dialysis units and in fact training on adherence to the drug regimen is presented, and only the drug compliance questionnaire, retrospective memory and prospective memory are completed by these individuals. Intervention groups include lavender, rosemary and orange, which will use these essential oils for three months a week. Drug compliance questionnaires, retrospective and prospective memory are completed by these individuals.

Description

Control group: In the control group, only the usual care of the dialysis units and in fact training on adherence to the drug regimen is presented, and only the drug compliance questionnaire, retrospective memory and prospective memory are completed by these individuals.

Description

Intervention group: Lavender group: In this group, the samples will use lavender essential oil (2%) three times a week for the usual care (they will be manufactured by Kashan Barij Essen). One hour after starting hemodialysis (to stabilize the patient's condition), 5 drops of lavender essential oil are poured into a gassus and placed within a distance of ten centimeters from the patient's nose. The lavender gas is put into a small 10cm container and the patient is asked to inhale it for 30 minutes. It should be noted that immediately after intervention (in other words at the end of four weeks) and one month after intervention, a retrospective-prospective memory questionnaire and drug compliance questionnaire are completed by referring to hemodialysis department. To control the essence of the essential oil, put the essential oils on a gas and put it in a small 10-centimeter container for the patients.

Description

Intervention group: Routine group: In this group, the samples will use 100% essential oil (for the production of Barij Essen, Kashan) three times a week, for a period of one month. One hour after starting hemodialysis (to stabilize the patient's condition), 5 drops of daily essential oil are placed on a gas and placed at a distance of ten centimeters from the patient's nose. The daily gas is dipped in a small 10cm container and the patient is instructed to inhale it for 30 minutes. It should be noted that immediately after intervention (in other words at the end of four weeks) and one month after intervention, a retrospective-prospective memory questionnaire and drug compliance questionnaire are completed by referring to hemodialysis department. To control the essence of the essential oil, put the essential oils on a gas and put it in a small 10-centimeter container for the patients.

Intervention group: Orange group: In this group, the samples will be used, in addition to receiving regular care, three times a week for orange essential oil (100%) (the construction of the Bariji Essential Oil Factory of Kashan). One hour after starting hemodialysis (to stabilize the patient's condition), 5 drops of orange essential oil are placed on a gas and placed within a distance of ten centimeters from the patient's nose. The orange gas is put into a small 10cm container and the patient is instructed to inhale it for 30 minutes. It should be noted that immediately after intervention (in other words at the end of four weeks) and one month after intervention, a retrospective-prospective memory questionnaire and drug compliance questionnaire are completed by referring to hemodialysis department. To control the essence of the essential oil, put the essential oils on a gas and put it in a small 10-centimeter container for the patients.
