Protocol summary

Study aim

develop, implement, and evaluate the impact of lifestyle education package in order to control metabolic syndrome components

Design

The intervention group received educational package consists of a three months' scheduled schedule (First month: face- to- face and pamphlets education program .Second month: 14 educational message ,Third month: Educational film). The control group received usual care by a physician in each visit, and fasting blood glucose will be assessed at baseline and after 3month.

Settings and conduct

from two health centers

Participants/Inclusion and exclusion criteria

72 women and men aged over 18 years with MetS

Intervention groups

enrolled through randomized sampling to either intervention group who take usual care plus a 3-month lifestyle modification intervention or control group.

Main outcome variables

Anthropometric indices, blood pressure, lipid profiles, and fasting blood glucose will be assessed at baseline and after 3 month.

Inclusion criteria:

minimum age of 18 years old The inclusion criteria were as follows: existence of $\geq 3/5$ elements for metabolic syndrome including: central obesity (men: ≥ 94 cm, women: ≥ 80 cm waist circumference); hypertension (systolic ≥ 130 mmHg, diastolic ≥ 85 mmHg and/or anti-hypertensive treatment); diabetes (fasting blood sugar (FBS) ≥ 100 mg/dL and/or anti-diabetic treatment); elevated triglycerides (TG) (≥ 150 mg/dL); low high-density lipoprotein (HDL) (men: < 40 mg/dL, women: < 50 mg/dL) and/or cholesterol-lowering treatment

Exclusion criteria:

level of education less than fifth grade hepatic diseases, hematologic diseases, renal failure (GFR < 30), Secondary causes of dyslipidemia, such as hypothyroidism and taking oral contraceptives, severe psychological illness, physical disability, known Cancer and treated type 1 diabetes, Alzheimer's and dementia Active TB disease, HIV
