Development and evaluation an Intervention Program for Prevention of Substance Abuse Based on Multi Theory Model(MTM) (in sequential exploratory mixed-method)

Protocol summary

Study aim

Determining the effect of an educational intervention program based on Multi Theory Model on substance abuse prevention.

Design

Quantitative sampling is done in two steps. In instrument psychometric, a sample will be systematically selected randomly from the Morgan table. There is no blinding. In the intervention section, the sample size will be 60 people and available sampling random assignment will be used.

Settings and conduct

In the qualitative phase, interviews will be conducted in the neighborhood mosque. Interviews are conducted as a focus group discussion. In the quantitative phase of the study, the pre-test questionnaire will be completed by visiting the homes of the selected individuals. Then the training program will be implemented and 6 months later the post-test questionnaires will be completed with the procedure of completing the pre-test stage. There is no blinding.

Participants/Inclusion and exclusion criteria

Inclusion criteria: Resident of the neighborhood, age group 15-50 years. Exclusion criteria: Addicted, mentally disabled and unable to cooperate

Intervention groups

The intervention group is trained based on the results of the qualitative stage and with the cooperation of experts who will determine the exact type and duration of the training. The intervention is done through an intervention group based on multi-theory model constructs at least 10 sessions in 6 months. The control group does not take any intervention, but after the end of the study, an educational package is provided to the control group.

Randomization description

Randomization will be performed using the stratified randomization method. Samples are divided into control and intervention groups. In addition to sufficient accuracy in the conditions of inclusion criteria, homogenization is based on the variables of age and sex status. Random allocation software is used for randomization. For concealment, we use allocation concealment, which is the method used to execute a random sequence on study participants, so that the assigned group is not known before the individual is assigned. Using opaque envelopes sealed in a random sequence (Sequentially numbered, sealed, opaque envelopes) in which each of the random sequences created is recorded on a card and the cards are placed in the envelopes respectively. In order to maintain a random sequence, the numbering on the outer surface of the envelopes is done in the same way. Finally, the letter envelopes are glued and placed in a box, respectively. At the beginning of the registration of participants, based on the order of entry of eligible participants into the study, one of the envelopes of the letter is opened in order and the assigned group of the participant is revealed.

An intervention group is a group that is randomly selected from the participants and is trained based on the results of the qualitative stage and with the cooperation of experts who will determine the exact type and duration of the training. The content of the training is designed based on the structures of the multi-theory model on the prevention of substance abuse.

Intervention group: The internship is done through group training of at least ten 90-minute sessions over 6 months and with appropriate methods (lectures, questions and answers and the use of educational videos).
