Protocol summary

Study aim

En Evaluation of diameter of lumbar vein, renal vein, and gonadal vein in left kidney nephrectomy on the back table and its relationship with the prevalence of varicocele

Design

The study is a randomized, community-based, and pragmatic clinical trial consisting of 30 patients in 2 groups with a double-blind design

Settings and conduct

This study will be carried out at Tabriz Imam Hospital in a two-blind manner

Participants/Inclusion and exclusion criteria

Inclusion criteria: Candidate for nephrectomy surgery, Not having congenital genitourinary problems. Exit criteria: History of inguinal herniorrhaphy, History of orchiopexy, Patients with a history of coagulation disorders.

Intervention groups

En Intervention group: Patients are evaluated for clinical varicocele before surgery, then underwent left-sided nephrectomy, during the operation, the diameter of the lumbar vein, renal vein and gonadal vein will be evaluated. Patients are re-evaluated for varicocele after 4 months

Description

Intervention group: In the intervention group, patients who underwent left-sided nephrectomy are evaluated for varicocele prevalence for 3 months. Varicocele is clinically divided into three grades: Grade 1 varicoceles are palpable only during Valsalva's maneuver; grade 2 varicoceles are palpable without Valsalva's maneuver, and grade 3 varicoceles are visible and palpable without Valsalva's maneuver.
