Protocol summary

Study aim

The effect of ultrafiltration profile on blood pressure control in patients undergoing hemodialysis

Design

cross over clinical trial with convenience sampling and single blind study on approximate 30 patients

Settings and conduct

Study in the field of hemodialysis will be performed in Shahid Beheshti hospital in Hamedan to investigate the effect of profiling on ultrafiltration. the type of profile that will apply to patients with intradialytic hypertension is interval with negative slope. Research sessions in each patient are 6 sessions, of which 3 sessions are with intervention and the other 3 sessions are without intervention. The study is single blind that patients after getting information about the research and accepting to attend the study they will not be informed of the routine or intervention of hemodialysis session.

Participants/Inclusion and exclusion criteria

Hemodialysis patients with intradialytic hypertension:
Hemodialysis patients with normal blood pressure during dialysis and intradialytic hypotension.

Intervention group: Apply interval profile with negative slope for ultrafiltration In three sessions of hemodialysis, which is applied from the beginning of hemodialysis until separation from the machine. blood pressure changes measured before starting hemodialysis, every hour during hemodialysis, and a quarter after completion. Na = 138 mEq adjusted, pump speed 250 and solution temperature 36.5 ° C adjusted during hemodialysis

Control group: Hemodialysis patients are hemodialyzed in the next three sessions without profile application in their ultrafiltration with Na = 138 mEq and pump speed of 250 and solution temperature 36.5 ° C adjusted during hemodialysis.
