The effect of educational program based on the Health ActionProcess Approach Model on consumption of fruit and vegetable in type 2 diabetes patients in Buin Zahra city.

Protocol summary

Study aim

Design, implementation and evaluation of health approach education that can improve the quality of life of diabetic patients.

Design

From among the centers covered in the city, four centers will be selected by lottery, and in these four centers, after the entry and exit conditions, the participants in the study will be selected by simple randomization and will be divided into two intervention and control groups. This study will be done on 100 people.

Settings and conduct

This study will be conducted in Buin Zahra city of Qazvin province and regarding the consumption of fruits and vegetables in diabetic patients.

Participants/Inclusion and exclusion criteria

Entry requirements: Having type 2 diabetes, being a volunteer. Age between 30 and 60 years. Not having complications of diabetes, having a mobile phone, being literate, suffering from the disease for one year. Exit conditions: Reluctance to participate in the study, having physical and mental disorders, participation in another study, immigration, complications of diabetes, addiction.

Intervention groups

The educational intervention includes a group training program that is presented by the researcher in four sessions for 30-35 minutes. The training will include lectures, slides, film and photo shows, group discussions, brainstorming, and questions and answers. For the control group, after completing the questionnaire in the second stage, a training session will be held and a training package including pamphlets, training videos and posters will be provided to them.

Randomization description

Buin Zahra city includes 11 comprehensive health service centers, out of which four centers will be selected by lottery, and then the names of the patients will be extracted and a list will be prepared, and those who do not have the conditions to participate in the study will be removed from the list. Among the remaining patients, people will be selected and entered into the study in a simple way (by lottery). Also, 12 people will be allocated to the intervention group and 12 people to the control group from two centers, and 13 people will be allocated to the intervention group and 13 people to the control group from the other two centers.

Description

Intervention group: For the intervention group, after completing the questionnaire and according to the results of the analysis of the path and weight of each structure and according to the standard time of a training session which is 30 to 45 minutes and will be implemented based on the training goals. In these sessions, the food pyramid and Food groups including fruits and vegetables, the benefits of consuming fruits

and vegetables, alternative behaviors will be presented through group discussion, existing obstacles will be removed by the method of brainstorming and verbal encouragement of patients, the positive experiences of patients following a diet containing fruits and vegetables. It will be discussed in a group, strategies for increasing access to fruits and vegetables, preparing a meal containing fruits and vegetables, and preparing a snack such as a fruit and vegetable salad will be taught. Also, a video on how to clean and disinfect fruits and vegetables will be taught. It will be distributed to patients.
