The Effectiveness of Cognitive Group Therapy on Fear of Negative Evaluation, Cognitive Flexibility and State-Trait Anxiety of Anxious Adolescents

Protocol summary

Study aim

Determining the Effectiveness of Cognitive Therapy Group on Fear of Negative Evaluation, Cognitive Flexibility and State-Trait Anxiety of Anxious Adolescents

Design

Non-randomized clinical trial with control group, parallel group, no blinding, on 30 patients. The intervention and comparison groups were studied in a period of time.

Settings and conduct

The venue was Ayatollah Hashemi Rafsanjani High School for Girls, Sari city, and the sample was selected in a non-random and purposeful manner, they were assigned to an experimental group of 15 people and a control group of 15 people, and all three tests were performed on the experimental and control groups. However, the experimental group underwent 12 sessions of cognitive group therapy, then the questionnaire was re-administered for both groups, after 45 days after the post-test, the tests were re-administered for the follow-up period.

Participants/Inclusion and exclusion criteria

Inclusion criteria: 1.Obtaining a score of at least 43 in the Spielberger Trait-Trait Anxiety Questionnaire 2. Age between 13 and 16 years Exclusion criteria: 1.Absence of more than two sessions in treatment

Intervention groups

The intervention group includes anxiety patients who receive cognitive therapy group. The control group is the anxiety patients who do not receive the cognitive therapy group.

Main outcome variables

Effect on the level of fear of negative evaluation, cognitive flexibility, trait state anxiety
