Efficacy of Topiramate in the treatment of Schizophrenia

Protocol summary

Summary

The aim of research is the study of Topiramate in the treatment of schizophrenia .Method of research is randomized ,triple blind ,placebo controlled clinical trial .Study population are inpatient and outpatient schizophrenic patients referred to Amirkabir Hospital and Imamreza clinic . Inclusion criteria:age range 15-50 ;diagnosis of schizophrenia according to DSM4-TR criteria and clinical interview by psychiatrist ; informed written consent letter; a score of at least 60 in PANSS Exclusion criteria :pregnancy;lactation; substance abuse;severe physical disease;epilepsy;use of Antiepileptic drugs ;contraindication of Topiramate Patients are randomly divided in two groups (intervention and control).Each group receive an atypical antipsychotic for 12 weeks .In addition to antipsychotic ,intervention group receive Topiramate 200mg/day ,and control group receive placebo.The time of intervention is 12 weeks from the start date.Primary outcome is change in PANSS scores.
