Investigating the effect of probiotic supplementation on progression of Carotid intima-media thickness after kidney transplantation, a triple blinded clinical trial study

Protocol summary

Study aim

Determination of probiotic supplementation effect on early atherosclerosis after kidney transplantation

Design

A controlled clinical trial with parallel groups, triple-blind, randomized, on 60 patients. The rand function of Excel software was used for randomization.

Settings and conduct

A randomized, triple-blind clinical trial that will be conducted on transplant patients after transplantation. The intervention group will receive a probiotic supplement for three months and the control group will receive a placebo once a day for three months. Carotid intima-media thickness will be measured at the beginning and end of the study and compared in the two groups. The researcher, participants, and the analyst are blinded in this study.

Participants/Inclusion and exclusion criteria

Inclusion criteria: First kidney transplant, at least three months after transplantation, no impairment of allograft function before study initiation
Exclusion criteria: Multiple transplants, graft loss during the first trimester, hepatitis, smoking, diabetes, pregnancy, history of cardiovascular disease, graft rejection before and after study entry, malignancy, liver cirrhosis

Intervention groups

The intervention group will take one probiotic tablet daily for three months. The control group will also receive one placebo tablet daily for three months.

Main outcome variables

Intima media carotid thickness; serum interleukin 6; hs_CRP

Inclusion criteria:	First kidney transplant at least three months after transplantation no impairment in allograft function prior to study entry
Exclusion criteria:	Multiple transplants graft loss during the first three months hepatitis smoking, diabetes pregnancy history of cardiovascular diseases graft rejection before and after study malignancy liver cirrhosis

Randomization (investigator's opinion)	Randomized
Randomization description	The study population will be completely randomly divided into 2 groups three months after the transplant and when kidney function has stabilized based on the physician's diagnosis. Randomization will be performed using a stratified blocked randomization method based on gender and age as the blocks. Blocks will be considered as 4.
Blinding (investigator's opinion)	Triple blinded
Blinding description	The study will be conducted in a triple-blind manner, so that the main investigator, the study population, and the results analyst will not be aware of the type of randomization in the groups and the type of intervention. The company producing the probiotic and placebo will send the product to the researcher in a coded form, and the researcher will not be aware of the coding until the end of the analysis. When the results are analyzed, the codes will be announced by the company and it will be clear what type of intervention each person received.

Intervention group: Will receive one probiotic supplement daily produced by Zist Tahmir Company. This supplement contains the following bacterial strains: Lactobacillus rhamnosus Lactobacillus plantarum Lactobacillus casei Lactobacillus helveticus Lactobacillus acidophilus Lactobacillus bulgaricus 109CFU Blend Lactobacillus gasseri Bifidobacterium bifidum Bifidobacterium lactis Bifidobacterium breve Bifidobacterium longum Streptococcus thermophile. Carotid intima-media thickness will be measured before the intervention and at the end of three months of probiotic consumption using Doppler ultrasound. Participants will be excluded from the study if they do not tolerate the probiotic.
