The effect of Topiramate on methamphetamine dependence: a double blind and placebo controlled trial

Protocol summary

Summary

The objective of this randomized, double-blind, placebo controlled study is to evaluate the efficacy of Topiramate in the treatment of methamphetamine dependence. 70 individuals who meet DSM-IV-TR criteria for methamphetamine dependence participate in this 10 weeks trial. The participants randomly will be allocated to two groups. Group 1(N=35) will receive 50 and 100mg/day Topiramate during the first and second weeks respectively, and then will receive 200 mg/day Topiramate. Group 2(N=35) will receive placebo for 10 weeks. Severity of addiction will be assessed by Addiction Severity Index(ASI) at the beginning and at the end of the study. Craving will be evaluated by a visual analogue craving scale every week . Urinary screening test for methamphetamine will be carried out each weeks.
