Comparison and effect of activation irrigation with Ultra X device , Wave Q device and conventional irrigation of root canal with endodontic needle on postoperative endodontic pain

Protocol summary

Study aim

The aim of this study was to evaluate and compare the effects of irrigant activation using the WaveQ device, the Ultra X device, and conventional syringe-and-needle irrigation on postoperative pain following root canal treatment

Design

This study was a phase III, randomized, double-blind, controlled clinical trial with parallel groups conducted on 39 patients. Eligible patients were randomly assigned to one of the three study groups (Groups 1, 2, 3)

Settings and conduct

Patients referred to the Endodontics Department of Islamic Azad University, Khorasgan Branch, who are candidates for root canal treatment of mandibular premolars and meet the inclusion criteria of the study, will be randomly assigned to one of the three groups (1, 2, or 3) after providing a full explanation of the study and obtaining written informed consent. Post-treatment pain intensity will be measured at 6, 12, 24, 48, and 72 hours, as well as one week after completion of treatment, using the Visual Analogue Scale (VAS).

Participants/Inclusion and exclusion criteria

In this randomized clinical trial, 39 patients with symptomatic irreversible pulpitis of mandibular premolars (Visual Analogue Scale ≥ 54) were enrolled. Following local anesthesia and isolation, canals were prepared to size F2 using rotary files, with 5.25% sodium hypochlorite (NaOCl) irrigation between each file. Patients were randomly assigned to three groups (n=13): Ultra X, Wave Q, and conventional needle irrigation. After single-visit obturation (gutta-percha/AH26) and temporary restoration, pain intensity was recorded via VAS at 6, 12, 24, 48, 72 hours, and 1 week. Data were analyzed using Kruskal-Wallis, Friedman, Chi-square/Fisher's exact and Mann-Whitney U tests.

Inclusion/Exclusion criteria
Inclusion criteria:
1. Patients with good systemic health and no significant medical conditions (ASA I or II).2. Patients diagnosed with irreversible pulpitis with spontaneous pain and symptomatic apical periodontitis in single-rooted, single-canal premolar teeth.3. Patients capable of understanding the Visual Analog Scale (VAS) for pain assessment.4. Patients aged between 18 and 55 years.5. Patients who are willing to participate in the study and are able to provide written informed consent.6. Patients who are candidates for single-visit endodontic treatment
Exclusion criteria:
1. Patients with systemic diseases.2. Pregnant women and breastfeeding mothers.3. Patients requiring antibiotic prophylaxis.4. Patients with psychiatric disorders.5. Patients with a history of allergy to the medications or materials used in the study.6. Patients who had taken antibiotics or analgesics within 12 hours prior to treatment.7. Patients with a current or previous history of abscess formation or swelling in the periapical region.8. Teeth presenting any of the following conditions were excluded from the study: - Open apex or a wide apical foramen. - Necrotic teeth. - Presence of a fistula or sinus tract. - Acute or chronic periapical abscess. - Teeth with Grade II or III mobility. - Non-restorable or hopeless teeth. - Abnormal root canal anatomy or calcified canals.9. Teeth in which procedural errors occurred during root canal treatment.10. Teeth in which apical patency could not be established.11. Patients who developed a flare-up following treatment.12. Patients with stress, as determined by the stress assessment test

Randomization description
The methodology section has been revised to provide detailed clarification regarding participant allocation. Randomization was performed using a simple lottery-based allocation method with opaque folded papers corresponding to each intervention group. Allocation was conducted prior to the irrigation procedure to minimize selection bias

Blinding (investigator's opinion)
Single blinded

Blinding description
This study was designed as a single-blind randomized clinical trial in which the patients were unaware of the irrigation activation method used during treatment. Due to the nature of the intervention, operator blinding was not feasible
