Comparing the effectiveness of emotion regulation-based play therapy with child-centered mindfulness-based intervention on adjustment, emotion management, and executive functions of children with attention deficit hyperactivity disorder (ADHD)

Protocol summary

Study aim

To compare the effectiveness of emotion regulation-based play therapy and child-centered mindfulness intervention on adjustment, emotion management, and executive functions in children with attention-deficit/hyperactivity disorder.

Design

This is a randomized, three-arm, controlled, pretest-posttest quasi-experimental trial involving 45 participants, randomly allocated to two intervention groups and one control group using sealed-envelope randomization.

Settings and conduct

The study will be conducted in counseling centers in Yasuj, Iran, among children with ADHD. A total of 45 eligible participants will be selected using purposive sampling and randomly allocated to two intervention groups and one control group. Data will be analyzed using SPSS software.

Participants/Inclusion and exclusion criteria

Inclusion Criteria: Children aged 6–12 years with a DSM-5 diagnosis of ADHD. Written parental informed consent and child assent. No related pharmacological or psychological treatment within the previous 6 months. Exclusion Criteria: Severe psychiatric comorbidities or learning disabilities. Current use of psychiatric medications. Withdrawal from the study or absence from more than two intervention sessions.

Intervention groups

Intervention Group 1: Participants will receive emotion-based play therapy in eight face-to-face group sessions, each lasting 90 minutes, delivered by the researcher according to the study protocol. Intervention Group 2: Participants will receive child-centered mindfulness training in eight face-to-face group sessions, each lasting 90 minutes. Control Group: Participants will receive no

intervention during the study period and will continue with routine care. Outcome assessments will be performed at the same time points as in the intervention groups.

Inclusion/Exclusion criteria
Inclusion criteria:
 Children aged 6–12 years. Diagnosis of attention-deficit/hyperactivity disorder (ADHD) according to DSM-5 criteria. Written informed consent provided by parents or legal guardians. Child's assent to participate in the study. No pharmacological or non-pharmacological interventions targeting executive functions or emotion regulation within the previous 6 months.
Exclusion criteria:
 Comorbid autism spectrum disorder, intellectual disability, or other severe psychiatric disorders. Severe learning disabilities interfering with participation in the intervention. Current use of psychiatric medications that may affect study outcomes. Withdrawal of parental consent or child assent during the study. Absence from more than two intervention sessions.

Randomization description
 Eligible participants will be selected through purposive sampling and randomly allocated in a 1:1:1 ratio to two intervention groups and one control group using simple randomization. The random allocation sequence will be generated before participant enrollment using the RAND function in Microsoft Excel. Allocation concealment will be ensured using sequentially numbered, sealed, opaque envelopes prepared by an independent researcher not

involved in participant recruitment or outcome assessment. After completion of the baseline assessment, each participant will be assigned to the next available envelope, which will determine group allocation.

Adaptability will be assessed at baseline, immediately after the intervention, and at the 2-month follow-up.

Method of measurement

Adaptability will be assessed using the Children's Adaptation Questionnaire developed by Dokhanchi (1998), consisting of 37 items rated on a 4-point Likert scale (0-3). Total scores range from 0 to 111, with higher scores indicating greater adaptability. Certain items are reverse-scored according to the questionnaire guidelines.

Emotion management

Timepoint

Emotion management will be assessed at baseline, immediately after the intervention, and at the 2-month follow-up.

Method of measurement

Emotion management will be assessed using the Child Emotion Management Questionnaire (Zeman et al., 2001). This 38-item instrument is rated on a 3-point Likert scale (rarely, sometimes, often) and includes three subscales: anger, sadness, and worry. The total score is calculated by summing all item scores, with higher scores indicating greater emotion management difficulties.

Executive functions

Timepoint

Executive functions will be assessed at baseline, immediately after the intervention, and at the 2-month follow-up.

Method of measurement

Executive functions will be assessed using the Executive Function Scale developed by Barclay (2012) for children and adolescents. The scale consists of 70 items rated on a 4-point Likert scale (never to always) and includes five subscales: time management, organization/problem solving, inhibition/self-control, self-motivation, and emotional regulation. The total score is calculated as the sum of all items, with higher scores indicating greater executive dysfunction.
